LIQUOR LICENCES ACT (R.S.A. c. L75)

LIQUOR LICENCES FEES REGULATIONS

Note: These Regulations are enabled under section 56 of the Liquor Licences Act, R.S.A. c. L75.

Fees

1. The fees payable in respect of a licence set out in Column 1 of the Schedule shall be those set out opposite in Column 2 of the Schedule.

Citation

2. These Regulations may be cited as the Liquor Licences Fees Regulations, Revised Regulations of Anguilla L75-1.

For a licence to sell liquor wholesale per annum	1,000
For a licence to sell liquor retail per annum	800
For a beer licence per annum	400
For a restaurant licence in respect of an entirely locally-owned restaurant per annum	800
For a restaurant licence in respect of a restaurant, other than an entirely locally-owned restaurant, per annum.....	1,600
For a temporary liquor licence to sell liquors either retail or wholesale, per day...	25
